Please note that the institute does not condone indiscipline. Any student who cannot cope with the institute's rules and regulations will be advised to leave.



#### **RULES AND REGULATIONS**

#### 1. DISCIPLINE

- a) Internal exams are compulsory to all students. No student will be registered for KNEC Examination (or other External Examinations) without coursework marks.
- b) Students are strictly prohibited from carrying dangerous weapons in and outside the institute.
- c) At no time in college should a student take alcohol, smoke cigarettes, chew miraa or be known to abuse any other drug.
- d) No student should be involved in fighting. Any degree of provocation should be reported immediately.
- e) All students are required to attend all the lectures/classes punctually. Any student who misses classes without a valid reason will face disciplinary committee.

#### 2. PROTECTION OF STUDENT FROM SEXUAL ABUSE

#### **NEW FUNDING MODEL FEE STRUCTURE & PAYMENT DETAILS**

Reliance and Sustainability

The government has rolled out a new student-centered funding model for universities and TVET institutions. Under the new model, universities and TVET institutions no longer receive block funding in form of grants based on differentiated unit cost (DUC) previously used. Instead, the government has resolved that institutions' funding will be apportioned to individual students according to their level of need: Vulnerable, Extremely Needy, Needy or Less Needy.

If you need Government financial support, you MUST make an application for consideration through the official website www.hef.co.ke. In case the government scholarship does not cover the entire cost of your program, the deficit will be met by your parent/guardian.
